2. Description/Information on Ingredients

General Description - Clear red liquid Odour – Fruity acidic aroma Specific Gravity – 1.18 – 1.20g/ml (typical result) pH – 3.3 – 3.7 (typical result)

Ingredients – A blend of nonhazardous liquids and powders.

3. First Aid Measures

Eyes - flush out with copious amounts of water for 15 minutes whilst separating the eyelids.

Skin - wash affected areas with warm water and soap

Inhalation – remove to fresh air; give artificial respiration if not breathing.

Ingestion - wash out mouth with water if conscious, also drink 2 glasses of water to dilute, seek medical attention.

Extinguishing media – Fight surrounding fire.

Avoid contact with eyes, skin, and inhalation. Wear protective clothing.

Method for cleaning up - cover with sand and sweep up, burn in a chemical incinerator equipped with afterburner.

Personal protective clothing to be worn i.e. overalls, rubber gloves. Keep in a sealed container in a cool dry place.

Ensure that eye wash stations are close to all work areas; also have easy and quick access to all wash areas.

Always wear personal protective equipment (ppe) as mentioned in section 7 'Handling and Storage' and follow any first aid measures where necessary as stated in section 4.
